Methodology – Canada's Best Law Firms 2026

Summary

- For the fourth time, **The Globe and Mail's Report on Business Magazine** and **Statista** are recognizing and rewarding Canada's Best Law Firms.
- Between 7th April and 30th May 2025, Statista conducted **broad surveys** (available in English and French) **among lawyers** (peer-to-peer survey) and **clients** (corporate legal departments) in **31 different fields of law**¹.
- About 25,000 lawyers as well as in-house lawyers/ legal executives working in legal departments of a company **across Canada** were actively invited to take part in the survey. Invitations were sent by e-mail with a personalized link that could only be used once. In addition, lawyers and clients could participate in the survey via an open link. In these cases, the participants had to validate themselves by providing a personal company e-mail address before their answers were included in the evaluation. The link was announced and made available online on The Globe and Mail's Report on Business Magazine's website (www.tgam.ca/BestLawFirms).
- **Peers** were asked to indicate up to five law firms per legal field they would recommend, if their company were not able to take on a client or his/her instructions (regardless of the reason). **Clients** were asked to name up to five law firms per legal field they would recommend based on their professional experience.
- The **Top 200 law firms in Canada** and the **top law firms for each legal field** were identified based on the **number of recommendations** they received from participants.
- The top lists of "Canada's Best Law Firms" were created in an **elaborate process**²: Participants' responses as well as the final selection of firms in each list were carefully reviewed. Self-recommendations (recommendation of one's own law firm) were prohibited, and these recommendations were not included in the evaluation.

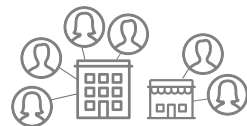

Basis

Lawyers, in-house lawyers or legal executives in a company received an **email invitation to participate in the survey** (via a personalized, non-sharable link).

Professionals (peers or clients) not actively contacted in the initial mailing were able to participate via an **open survey link incl. an email validation** at the end of the survey.¹
